- e) Caste/Category Certificate (if applicable; and issued NOT before one year in case of OBC)
- f) Certificate of Children of Ex-Serviceman / Armed Force Personnel/Meritorious Sportsperson Certificate/Disability Certificate (if applicable)
- g) Enrolment Certificate
- h) 3 (three) passport photos
