**Subject: Nomination of part-time Members under Section 4(4)(d) of the National Dental Commission Act, 2023 – reg.**

Sir/Madam,

I am directed to refer to the subject mentioned above and to say that the Ministry is in the process of appointing part-time Members of the National Dental Commission (NDC) under Section 4(4)(d) of the National Dental Commission Act, 2023. The said provision stipulates the nomination of:

*"two dental faculties, from any Central or State or Autonomous Government Institutes, doing exemplary work in the field of dental education, to be nominated by the Central Government, in such manner as may be prescribed, for a term of four years."*

2. Further, Rule 6 of the National Dental Commission Rules, 2024 prescribes the manner for appointment of part-time Members, inter alia, providing that *"the Central Government shall appoint two part-time Members from amongst dental faculty of the level of Associate Professor or above. It also provides that nominations are to be invited from Central, State, and Autonomous Government Institutes."*

3. Accordingly, it is requested to furnish nominations of eligible dental faculty from the level of Associate Professor or above, from State Government Dental Colleges/UT Government Dental Colleges/Universities/Hospitals or Autonomous Government Institutes under their administrative control, who are doing exemplary work in the field of dental education.

4. It is requested that the nominations may kindly be forwarded to this Ministry within 10 days of the issuance of this letter.
