INFORMATION FOR CANDIDATES FOR SELECTION OF FEMALE HEALTH WORKERS COURSE.

Scheme of written test / examination:

- 1. The qualifying examination for nomination to FHW course is 10+2 / equivalent examination.
- 2. There shall be written examination with 1. English and 2. General Knowledge carrying 40 marks each and the standard of written test shall be same as in the case of class XII conducted by the Council of Higher Secondary Education, Manipur. The total marks of written test shall be 80 (eighty) in 2 hours duration. Answer shall be of multiple choice type and there shall not be any negative marking. 20 (twenty) marks will be for vivavoce.
- 3. Each question will carry 1 (one) mark. There will be no negative markings. Answers are to be $\sqrt{\ }$ in the box. More than 1(one) $\sqrt{\ }$ overwriting/ cancellation and change of answer will be awarded zero.
- 4. Use Blue/Black ball point pen. The duration of the written test will be of 2 (two) hours. No candidate shall be allowed to leave the examination hall till the completion of the examination.
- 5. The examination fee for the competitive test shall be Rs 300 for General / OBC and Rs 200/- for S.C. / S.T. candidates by cash.
- 6. Merit list based on the performance in the written test and viva-voce separately for unreserved/General, OBC, ST, & SC Candidates as per reservation policy of the State Government as per number of seat available.
