4. **Eligibility Criteria for FHW Training course:**

i). The minimum age for admission shall be 17 years and not exceeding 35 years on or before 31st December of the year in which admission is sought

ii). The minimum educational requirement shall be 10+2 in Arts./.(Mathematics, Physics, Chemistry, Biology, Biotechnology, Economics, Political Science, History, Geography, Business Studies, Accountancy, Home Science, Sociology, Psychology, and Philosophy) and English Core/English Elective or Science or Health care Science – Vocational stream only passing out from an Institute recognized by Board/Council of Higher Secondary Education or its equivalent body/Council including National Institute of Open Schools.

iii). Student shall be medically fit.

(iv). Students shall be admitted once in a year.
