Imphal, the 20th July, 2019

No.7/14/2019-M(SL): Whereas Rule 10 (4), 10(5), 10(6) of Manipur Health Service Rules, 1982 prescribe the norms for fixation of seniority of Manipur Health Service Officers appointed by direct recruitment and by promotion in order of merit recommended by MPSC/Selection Committee and in accordance with a roster based on the occurrence of the vacancies in respect of direct recruits and promotees. The said rules are reproduced below for ready reference of all concerned:

Rule 10(4): *The inter-se-seniority of persons appointed by direct recruitment under Rule 7 shall be regulated by the order of merit specified in the list of candidates recommended by the Commission;*

Provided that all persons appointed on the basis of an earlier selection shall rank senior to all persons appointed on the basis of a subsequent selection.

Rule 10(5): *The inter-se-seniority of persons appointed by promotion under Rules 7 shall be regulated by the order of merit of officers recommended by Selection Committee;*

Provided that all persons appointed on the basis of an earlier select list shall rank senior to all persons appointed on the basis of a subsequent select list.

Rule 10(6): *The seniority of officers mentioned in sub-rule (4) above in relation to the officers mentioned in sub-rule(5) above shall be regulated in accordance with a roster based on the occurrence of vacancies which by these rules are to be filled by direct recruitment and by promotion respectively;*

Provided that the roster shall start with a promotee or promotees.

2. Whereas as per the existing Manipur Health Service Rules, 1982 as amended from time to time, the Specialist posts in MHS are to be filled up 75% by promotion and 25% by direct recruitment and the Non-Specialist posts in MHS are to be filled up 100% by promotion ; and

3. Whereas appointments by promotion to MHS Grade-III have been made from time to time; and

4. Whereas subject-wise creation/segregation of Specialist posts in MHS Grade-III took place in the year 2013-14 vide Notification No.1/51/83-MHS/DP(I) dated 24/03/2014 issued by Department of Personnel, Government of Manipur and the same was notified in Gazette on 27/03/2014; and

5. Whereas after the said subject-wise creation /segregation of specialist posts in MHS Grade-III, appointments have been made to MHS Grade-III i.e. (i) appointment by promotion to Non-Specialist posts(100% promotional posts), (ii) appointment by promotion to Specialist posts against 75% promotion quota and (iii) appointment to Specialist posts against 25% direct recruitment quota respectively ; and

6. Whereas under the provisions of Rule 10(4), 10(5) and 10(6) of Manipur Health Service Rules, 1982, a Tentative Seniority list of MHS Grade-III appointed as on 04/08/2016 drawn up in accordance with a roster based on the occurrence of vacancies against which the existing incumbents have been appointed, is notified as below:
