3. The 2nd Party shall work or perform duties assigned to him/her from time to time under supervision and control of the 1st Party or such officer authorised by the 1st Party;

- 4. The 2nd Party shall not, during the term of this Agreement, engage himself directly or indirectly in other employment whatsoever;
- 5. The above parties agree that the service rules presently governing the State Government employees shall not apply to the 2nd Party;
- 6. The 2nd Party shall have no right to claim or shall not make any claim for regular appointment/absorption on the basis of his engagement for the implementation of the Legal Cell. His service shall automatically cease immediately at the end of the contract period unless terminated earlier under clause 10:

- 7. The 2nd Party shall execute an Undertaking which is appended hereto in respect of his term of engagement for implementation of the said Scheme/Work. The said Undertaking will form a part of this Agreement;
- 8. The 2nd Party may apply for leave of one day casual leave in a month and in case of more than one day on the ground of illness, he may be granted at half remuneration not exceeding one week, i.e. total remuneration payable per month \div 30 days x $\frac{1}{2}$ x number of days of leave on the ground of illness.
