**No. DME-18/1/2026-HEALTH:** In continuation of this Directorate Notification of even number dated 05-09-2026, the available seats for the State Government quota at RIMS, JNIMS, CMC, SAHS & RDC, Guwahati in the 2<sup>nd</sup> Round of the Manipur Medical e-Counselling 2026-27 is notified as follows:

2. Under Rule 2(xi) of the Manipur MBBS/BDS/BASLP (Selection of Candidates for Nomination) Rules, 2021 (amended up to the year 2025), a Meritorious Reserved Candidate (MRC) means a candidate belonging to a reserved category (SC/ST/OBC) who is selected on merit and placed in Unreserved (UR) category. The vacant MRC seats will be filled under Rule 20(iv) of the said Rules, which reads as follows:

*"An MRC can select a Seat earmarked for the reserved category to which he belongs so as to not disadvantage him against less meritorious reserved category candidates. Such reserved category seat selected by MRC shall be treated as part of the UR category only."*



*Provided that the UR Seat which would have been allotted to the said MRC, had he not selected the reserved category Seat, shall be treated as a reserved category Seat and filled up by a candidate in the reserved category list under Rule 20.iii.*

*Provided that if an MRC who availed the benefit as above has vacated the UR Seat, the Vacant Seat shall be converted back to the original reserved category seat and filled up by a candidate in the reserved category list under Rule 20.iii.*

*Provided that if a reserved category candidate has availed the benefit as above, the vacant reserved category seat shall be converted back to the original UR Seat and filled up by a candidate in the UR category list under Rule 20.iii."*

3. Candidates are further instructed to thoroughly read the "Technical Instructions for 2<sup>nd</sup> Round Manipur Medical e-Counselling" given in Annexure-A, for the Second Round of Manipur Medical e-Counselling 2026-27.
