No. DME-18/1/2026-HEALTH: In connection with the 2nd Round of the Manipur Medical e-Counselling for the academic Session 2026–27, it is to notify the lists of candidates allotted in State Government Quota seats for MBBS/BDS/BASLP and MBBS under Management Quota seats at SAHS as Annexure-A and Annexure-B, respectively.

2. Candidates who have been allotted seats are instructed to log in to the web-based application portal at <https://manipurmc.mn.gov.in> and download their respective Provisional Allotment Letter and complete the admission/joining formalities within the stipulated period as notified. The link to the web-based application is also available on the website <https://manipurhealthdirectorates.mn.gov.in/>.

3. Candidates who reject or do not join the allotted seat shall not be allowed to claim the same seat in further rounds of counselling, as per the notified counselling guidelines.

4. If a candidate fails to join the institute after allotment of seat in the 2nd round within the stipulated time, refundable Security Fees will be forfeited. Also, Security Fees will be forfeited if the admission gets cancelled for any reason, i.e., if the candidate gives wrong information at the time of registration, based on which a seat may be allotted, and the admission is later cancelled by college authorities.

5. Candidates who have opted for “FLOAT” and whose seat is not upgraded in the 2nd Round may log in to the Manipur Medical e-Counselling portal and exercise either of the following options:

- a. “FREEZE” the previously allotted seat and continue with the said seat; or
- b. “SURRENDER” the previously allotted seat and participate in the subsequent round of counselling; or
- c. Continue with the “FLOAT” for seeking upgradation in the 3rd Round.

Candidates opting to continue with “FLOAT” shall be required to freshly exercise and lock their Seat Choice(s) for the 3rd Round within the prescribed schedule. The Seat Choice(s) exercised for the 2nd Round shall not automatically be considered for the 3rd Round. In case a Float candidate surrenders the allotted seat after the 2nd Round, the refundable Security Deposit shall be forfeited. Once the seat is surrendered, the candidate shall have no claim over the surrendered seat.

6. Allotted candidates in the 2nd round of counselling shall follow the procedure prescribed in the “**2nd Round Allotment Technical Instructions & User Manual**” (Annexure-C) and exercise the **Freeze/Float/Reject mechanism** by the stipulated timeline, i.e., 18th Sept, 2026.
