It is further informed that:

- i). Any eligible candidate or his/her authorised attendant who are absent on the previous counselling shall not be allowed to attend the subsequent counselling/s.
- ii). Any eligible candidate or his/her authorised attendant should produce all the necessary original certificates at the time of counselling failing which his/her right to get a seat will be forfeited and chance will be given to the next eligible candidate. No claim shall be entertained latter on.
- iii). In case of authorisation, candidates should obtained the prescribed authorisation letter from Directorate of Health Services, Lamphelpat before the date of counselling. The prescribed authorisation letter shall not be issued to any candidate on the date/day of counselling.
- iv). Roster Point of 200 and the existing reservation policy of Government of Manipur shall be adopted in the allotment of available seats.
- v). The Degree and nature of disability for PwD candidates shall be assessed by the duly constituted State Medical Board, Directorate of Health Services, Lamphelpat prior to the date of counselling.
- vi). The filled up application Form should be submitted to the Directorate of Health Services on or before the last date of submission along with necessary fee (cash only).
- vii). Instruction/guidelines issued by MCC of DGHS, Govt. of India from time to time shall be followed while conducting the State Counselling for filling up the MBBS/BDS/BASLP courses.
