F.No.G / Rect.(S/N) /2022-DHS: In pursuance of Government of Manipur, Sect: Health Dept. letter No. MED-308 /4 / 2022-HS-HEALTH dated 17-10-2022, eligible & intending candidates are invited to apply for contractual engagement in the following posts in Health Department.

1	Medical Officer: 200 (two hundred) posts. Remuneration @ ₹26,550/- per month as per FD(PIC)'s norms [50% of 1st cell in the level of pay matrix under RoP-2019].	i) MBBS qualification recognized by MCI/ NMC. ii) Completion of rotating internship. iii) Possession of Registration Certificate issued by MCI/ NMC/ MMC.
2	Staff Nurse: 300 (three hundred) posts. Remuneration @ ₹ 17,700/- per month as per FD(PIC)'s norms [50% of 1st cell in the level of pay matrix under RoP-2019].	A-grade Nurse (Senior certificate in Nursing & Midwifery from recognized Institute/University) registered under Manipur Nursing Council. Midwifery certificate is not required for Male Nurse.

Number of posts may increase or decrease subject to requirement & number of vacancies.

2. Recruited staff shall mandatorily serve for 03 years in health centres in difficult & remote areas which are listed as Zone-C & Zone-D in the Annexure to Transfer & Posting Policy, 2018 of Department of Health & FW and AYUSH issued vide Govt. Order No. 2/6/2017-M(T&P) Part dated 31-03-2018.

3. Recruited staff shall be considered for regularization under Health Department after 05 years on fulfilment of strictly monitored conditions of efficiency, competency, good conduct, apolitical conduct, etc. as per Govt. O.M. No. RRDP-30/1/2021-DP-DP: dated 16-07-2021.

4. Priority shall be given to those persons engaged by State Government for COVID related duties & have completed 100 days of COVID duties in the form of extending benefit of 10 additional marks to the total marks obtained in the examination. Candidates concerned shall submit certificates in the Format attached to the Application Form.

5. Upper Age limit: 38 years relaxable by 03 years(for OBC), 05 years(for SC & ST) & 10 years (for PWD). Upper age limit is relaxable for regular Government employees as per Rules. Upper age limit will be further relaxed by 03 more years for ALL categories due to COVID pandemic. Qualifying date for age limit will be as on the date of notification.

6. Existing extant Reservation norms of State Government will be followed.

7. Intending candidates shall download the Application Forms from the website www.manipurhealthdirectorates.mn.gov.in & print in A4 SIZE PAPER. There will be NO sale of Forms physically.

8. Candidates shall PHYSICALLY submit duly filled APPLICATION FORMS & supporting DOCUMENTS in the Directorate of Health Services, Lamphelpat from 10AM to 4PM DAILY on working days as per schedules given below on cash payment of ₹ 1000/- (₹500/- for SC/ST & ₹400 for PWD) as application fees.

9. Candidates for Staff Nurse posts shall mandatorily apply for SPONSORSHIP by the Employment Exchange. In-service candidates shall apply with 'no objection certificate' from their Employers.

10. Incomplete Applications will be summarily rejected. Application Fees, once collected, shall not be refunded.

11. Date, Time & Scheme of Examination will be notified in the website.

12. Candidates shall frequently visit the official website www.manipurhealthdirectorates.mn.gov.in for any updates. This Directorate shall not be responsible if any candidate fails to visit the website & misses any information.
