No.104/1/2024-DHS: It is informed to all that the **Round 3 counselling for State Government nomination for admission to MBBS, BDS & BASLP courses 2024**, will be held as per schedule given below:

2. Candidates will also be allowed to attend the Counselling through Video Conference from any of the following four NIC District Units located in the DC Offices of (i) Churachandpur (for Churachandpur and Pherzawl), (ii) Jiribam, (iii) Kangpokpi & (iv) Tengnoupal.

3. The following candidates are informed to attend the said counselling:

4. Candidates/authorised representative shall bring the following documents in **original** on the day of counselling, failing which, they will not be allowed to attend:

- NEET UG 2024 Re-revised score card (Date of declaration of result as on 26.07.2024)
- Class X Certificate as age proof
- Class XII mark sheet
- Domicile Certificate of candidate/Permanent Residential Certificate of parents /Government Employment Certificate of parents (whichever is applicable)
- Caste/Category Certificate (if applicable; and issued NOT before one year in case of OBC)
- Enrolment Certificate
- 3 (three) passport photos

5. Candidates failing to attend in previous round(s) of Counselling shall NOT be allowed to attend in further rounds of counselling.

6. As per the **NEET UG Counselling 2024 Information Bulletin and Counselling Scheme released by the Medical Counselling Committee, DGHS, Government of India**, upgradation of seats allotted in previous rounds of counselling will be allowed up to Round 3 Counselling. **Further, Candidates who have joined Round 3 seat, shall not be allowed to vacate from allotted seat. Candidates allotted a seat in Round 3 and who have not joined the Institute, are ineligible to participate in any further rounds of Counselling.**
